THE CONSTRUCTION PERMIT FOR THE STATION'S OMNIDIRECTIONAL ANTENNA IN ITS MAXIMIZATION APPLICATION THAT WAS GRANTED ON JANUARY 15, 2009, A SHORT TIME AFTER THE FCC'S MAPS WERE PREPARED, WAS THE CONSTRUCTION PERMIT IN EFFECT ON APRIL 1, 2009. SEE BMPCDT-20080620AJZ. AS SHOWN IN LICENSE AUTHORIZATIONS BLCT-20030415ACC (ANALOG CONTOUR) AND BLCDT-20090602ABA (DIGITAL CONTOUR) THE STATION'S ANALOG CONTOUR IS WHOLLY CONTAINED WITHIN THE STATION'S DIGITAL CONTOUR. CONSEQUENTLY, THERE WAS NO PREDICTED SERVICE LOSS AREA BECAUSE NO ANALOG VIEWERS WERE PREDICTED TO LOSE SERVICE. AS A RESULT, THE STATION DETERMINED THAT SERVICE NOTICES WERE NOT REQUIRED, WOULD HAVE BEEN INACCURATE, AND WOULD HAVE CAUSED VIEWER CONFUSION HAD THEY AIRED SO THE STATION DID NOT AIR SERVICE LOSS NOTICES.
